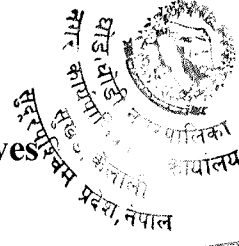

1. **Ghodaghodi Municipality has allocated funds** towards the cost of **The Construction of Multi-Purpose Administrative Building** and intends to apply part of the funds to cover eligible payments under the Contract for **NCB/GMU/12/082/083**. Bidding is open to all eligible as per Section V of bidding document.
2. **Ghodaghodi Municipality** invites sealed bids or electronic bids from eligible bidders for the construction of **The Construction of Multi-Purpose Administrative Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 6,12,81,850.00**
- Minimum Work experience of similar size and nature: **One no of project with project value of NRs. 7,35,38,200.00**
- **Bid Capacity: 11,03,00,000.00**
- **Key Activities: 1. Reinforcement Work: 178.00 MT**
2. Plain cement concrete M25 (1:1:2): 1004.00 CUM

3. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the account as specified below .

6. Pre-bid meeting shall not be held.
7. Electronic bids must be submitted to the office of **Ghodaghodi Municipality, Sukhad, Kailali** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00** on **2083/02/27 (10th June 2026)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2083/02/27 (10th June 2026)** at the office of **Ghodaghodi Municipality, Sukhad, Kailali**. Bids must be valid for a period of **120 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **34,32,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
